The Autonomous University of the State of Hidalgo (UAEH) and the Universität Kassel have the intention to intensify their mutual academic, scientific and cultural interests by establishing and reinforcing the relationship and understanding between Mexico and Germany. This Memorandum of Understanding between the UAEH and the Universität Kassel, Faculty of Economics and Management, Institute of Vocational and Business Education contributes to international development, cooperation, cultural and academic exchange, and strengthens friendship between the parties. It extends the mutual cooperation interests already stipulated and signed in the Letter of Intent on January 31, in the year of 2017.

Both parties agree to make an effort to develop the following forms of cooperation in the field of vocational and educational education:

- To encourage cultural, academic and scientific exchange
- To start and develop joint projects
- To spread artistic and cultural activities
- To enhance academic exchanges in congresses, events, seminars, fairs, exhibitions and activities that take place in both countries
- To support the learning of language and culture
- Any other activity of mutual interest.


Each party agrees to work collaboratively for the development of specific objectives regarding the previous points. This includes logistics and management details, as well the availability of financial means to reach a successful implementation of the cooperation.

Further fields of mutual interest may be included in the future collaboration, such as organic agricultural science, knowledge transfer and language studies. Each collaboration in one of these fields requires a specific memorandum of understanding to be duly signed by the authorized parties.

This Memorandum of Understanding will be valid for three (3) years and may be extended by written consent of the authorized parties.

This Memorandum was read and signed in duplicate, in Spanish and in English in the city of Pachuca, Mexico on February, 20th 2017.


