



COOPERATION INTER-UNIVERSITY FRAMEWORK AGREEMENT BETWEEN

THE UNIVERSITE PARIS XII VAL DE MARNE KNOWN AS UNIVERSITE PARIS-EST CRETEIL (UPEC)

AND

UNIVERSIDAD AUTÓNOMA DEL ESTADO DE HIDALGO (UAEH)

In view of the cooperation agreements, between Mexico and France, the following is agreed:

ARTICLE 1 - The Parties

In accordance with the powers conferred upon it,

The Université Paris-Est Créteil Val-de-Marne (UPEC) and Universidad Autónoma del Estado de Hidalgo (UAEH) establish cooperation relations between their constitutive bodies.

ARTICLE 2 - Collaboration

While complying with the applicable legislative and regulatory provisions in each university and in the respective countries, UAEH and UPEC endeavor to promote these cooperation relations in the following forms:

- Exchange of students;
- Exchange of members of teaching staff, academic researchers, members of administrative staff, for periods of time determined by the regulations that apply to each institution;
- Creation and joint management of research and activity programs, exchange of teaching staff and academic researchers, as part of these programs;

- Joint organization of internships, seminars and symposia;
- Exchange of information of any kind, documentation, publications and research results.

ARTICLE 3 - Social security

The students, members of teaching staff, academic researchers and members of administrative staff benefiting from these exchanges shall have a health insurance covering hospitalization, accidents, repatriation and civil liability during their travels and stays in the host country. If the social insurances they are covered by as part of their activities or status are insufficient in the light of the abovementioned requirements, they shall take out an appropriate individual insurance.

ARTICLE 4 - Means

All request related to means is to be indicated as an appendix presented to the parties.

ARTICLE 5 - Duration of the agreement

This agreement shall come into force on the date of its signing by the Parties. It is valid for five (5) years.

This agreement may be continued beyond the term only by an amendment signed by both parties.

This agreement is drawn up in English in two copies.

Every modification of the present document shall be carried out through a written document signed by the contracting institutions.
